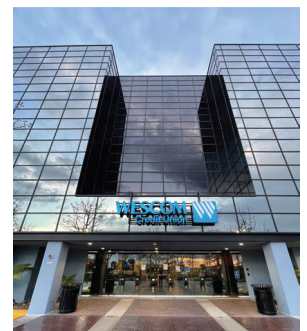
Backup Data Center: Phoenix, AZ
